## President's Letter



Dear Friends of La Salle Academy,

Our LSA community was so excited to start the 2019 – 2020 school year. We watched for a whole year, as the Sisters of Saint Joseph Student Center became a reality, and for the first time in seventeen years, we had the opportunity to gather as one in a single space in our own building. Throughout the year, we took advantage of every opportunity to use the Student Center starting with our Rooftop Soiree thanking our Board of Trustees and donors who helped make the center a reality. This was followed by our Mass of Thanksgiving. Msgr. David Diamond, twin of our much-loved principal, Teresa Diamond, was our celebrant. We went from church to the Sister of Saint Joseph Student Center. The day of our Thanksgiving dinner we learned that we would not be able to use all of the space in Father Gallagher's Hall in St. Michael's lower church, so we immediately set up the Student Center for our eighth grade and their families to have dinner. 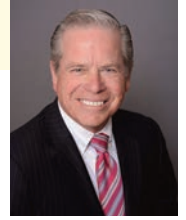



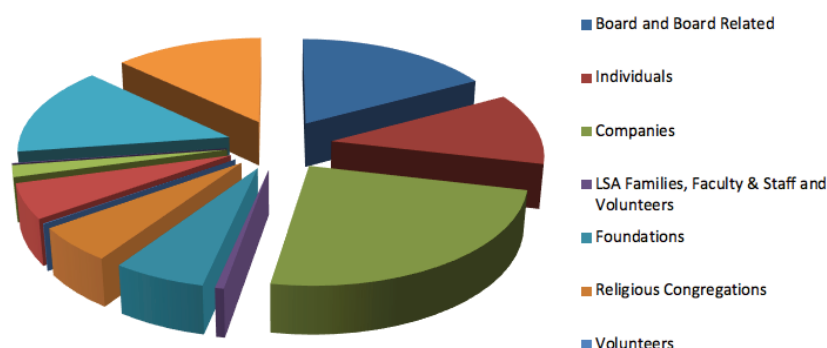
## Financial Summary 2019 - 2020

La Salle Academy is deeply grateful to our Board of Trustees and to our Benefactors who have made the 2019- 2020 year a fundraising success, even in the face of great odds. Because of your generosity, La Salle Academy was able to reach our fundraising goals. Though the global pandemic and ensuing closures changed how we ended our year, the Lasallian spirit continued. We are sincerely thankful for your help in making a difference in each of our students' lives. LSA spent \$2,300,000 for operations and our Academic Program, and much love, sweat, tears and donations to complete and open the SSJ Student Center.

### Gifts And Grants By Source Of Funds

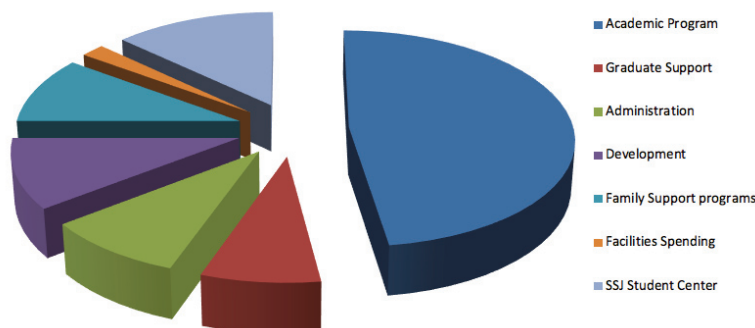
